Pursuant to Texas law, a Principal or Principal's designee shall inform each educator who has responsibility for, or is under the direction and supervision of an educator who has responsibility for, the instruction of a student who has engaged in any violation for which the student may be expelled or placed in a DAEP of the student's misconduct.

Pursuant to Texas law, each educator shall keep the information confidential from any person not entitled to the information, except that the educator may share the information with the student's parent or guardian as provided for by state or federal law. The State Board of Educator Certification may revoke or suspend the certification of an educator who intentionally violates the confidentiality provisions.
